

RIDER BGS-L BASIC GENERATION SERVICE - LARGE
(Applicable to Customers at or above 1,000 kilowatts)

PURPOSE

Rider BGS-L – Basic Generation Service – Large (Rider BGS-L), along with Delivery Service (DS) and Transmission Service (TS) tariffs contained within this Schedule, represents a continuation of bundled service for Customers in accordance with Section 16-103 (220 ILCS 5/16-103) of the Illinois Public Utilities Act (Act). Service under Rider BGS-L will be available to Customers served under Rate DS-4 Large General Delivery Service (Rate DS-4). This Rider provides Customers with electric power and energy supply from the Company procured pursuant to the provisions of the Company’s Market Value of Power and Energy (Rider MV) tariff.

AVAILABILITY

This Rider is available, on and after January 2, 2007, to any Customer with a maximum monthly Demand equal to or greater than 1,000 kilowatts (kW) in at least one of the 12 consecutive monthly Billing Periods ending no later than seven months prior to the Auction Commencement Date as described in Rider MV, and pursuant to the requirements in the Terms and Conditions related to this Rider, that elects to purchase electric power and energy supply from the Company. Customer shall also have complied with the requirements specified in Rider MV. Customers with Demands at or above 3,000 kW, qualifying for service under this Rider, must sign a non-binding pre-qualification form to include their load in the BGS-LFP Load as described in Rider MV to be eligible to enroll for supply service under this Rider during the Open Enrollment Period for the applicable Annual Contract Period.

SERVICE CLASSIFICATIONS

The Customer’s Delivery Service Rate is used to determine the Customer’s service classification if the Customer enrolls for service under this Rider. Following is the Rider BGS-L service classification and corresponding Delivery Service Rate – there are additional delineations for varying Delivery Voltages as shown in Rider MV, Appendix A.

ELECTRIC POWER AND ENERGY SUPPLY PRICING METHODOLOGY

Rider MV is used to determine the electric power and energy supply prices for this Rider. For the BGS-4 service classification, electric power and energy supply prices shall be billed on a per kilowatt-hour (kWh) basis. A monthly Market Value Adjustment (MVA), as defined in Rider MV, if applicable, will be applied to Rider BGS-L Customers to align electric power and energy supply costs for the BGS-LFP Category, as defined in Rider MV, with Customer billings. The peak and off-peak periods are as defined in Rider MV.

CHARGES

For each Billing Period, Customer shall pay for electric power and energy supply at prices defined in Rider MV and stated on the applicable Retail Supply Charge Informational Filing. In addition, other charges will apply to Customers taking service under this Rider, including but not limited to, MVA, TS and any other applicable charges the Customer is required to pay as specified in the Delivery Service Rate.

TERMS OF PAYMENT

Customer bills for service under this Rider shall be rendered and payments due in accordance with the Payment of Bills and Late Payments provision of the Customer Terms and Conditions.

TERMS AND CONDITIONS

1. Service Obligation

A. Initial Annual Contract Period

Service under this Rider shall commence at the beginning of the hour ending 0100 on January 2, 2007, for those Customers that have enrolled for electric power and energy supply service under this Rider during the Open Enrollment Period as defined in Rider MV. Service under this Rider will continue for the Annual Contract Period as defined in Rider MV.

Service under this Rider shall commence at the beginning of the hour ending 0100 on January 2, 2007, for those Customers with Demands at or above 3,000 kW, that have signed the non-binding pre-qualification form to include their load in the BGS-LFP Load, that have not opted for supply service from a RES nor opted for supply service under Rider RTP-L or Rider RTP-LI during the Open Enrollment Period as defined in Rider MV. Service under this Rider will continue for the Annual Contract Period as defined in Rider MV.

RIDER BGS-L BASIC GENERATION SERVICE - LARGE
(Applicable to Customers at or above 1,000 kilowatts)

Service under this Rider shall commence at the beginning of the hour ending 0100 on January 2, 2007, for those Customers with Demands at or above 1,000 kW but less than 3,000 kW who have not opted for supply service from a RES nor opted for supply service under Rider RTP-L or Rider RTP-LI during the Open Enrollment Period as defined in Rider MV. Service under this Rider will continue for the Annual Contract Period as defined in Rider MV.

B. Subsequent Annual Contract Periods

Customers qualifying for service under this Rider with Demands at or above 3,000 kW who have signed the non-binding pre-qualification form to include their load in the BGS-LFP Load, will automatically be enrolled for the next Annual Contract Period unless the Customer has opted for supply service from a RES or opted for supply service under Rider RTP-L or Rider RTP-LI during the Open Enrollment Period as defined in Rider MV. Service under this Rider will continue for the Annual Contract Period as defined in Rider MV.

Rate DS-4 Customers with Demands at or above 1,000 kW but less than 3,000 kW qualifying for service under this Rider will be automatically re-enrolled for the next Annual Contract Period unless the Customer has opted for supply service from a RES or opted for supply service under Rider RTP-L or Rider RTP-LI during the Open Enrollment Period as defined in Rider MV. Service under this Rider will continue for the Annual Contract Period as defined in Rider MV.

Customers with Demands at or above 1,000 kW but less than 3,000 kW qualifying for service under this Rider will be automatically enrolled for the next Annual Contract Period unless the Customer has opted for supply service from a RES or opted for supply service under Rider RTP-L or Rider RTP-LI during the Open Enrollment Period as defined in Rider MV for the next Annual Contract Period. Service under this Rider will continue for the Annual Contract Period as defined in Rider MV.

2. Switching Rules

Customers electing to switch between electric power and energy supply options shall be subject to the Company's Direct Access Service Request (DASR) procedures, in accordance with the Switching Suppliers and DASR Procedures provision of the Customer Terms and Conditions, and the Retail Customer Switching Rules in Rider MV. If proper DASR notice is not provided, the Company shall follow the unscheduled switching provisions. Rider MV contains the rules for Customers selecting electric power and energy supply requirements from the Company. The Customer will be charged for each switch at the rate specified in Miscellaneous Fees and Charges.

3. New Customers

Applicants for service under Rate DS-4, who are new to the Company, will be given the option of Rider BGS-L, Rider RTP-L or Rider RTP-LI if they choose electric power and energy supply service from the Company. (New is defined as an account served from a new distribution extension or a successor account.) Any Customer choosing service under this Rider shall be obligated to fulfill any remaining term under the Annual Contract Period as defined in Rider MV.

4. Partial Requirements Supply Service

Customers requesting Partial Requirements Supply Service (PRSS), as defined in Rider MV, will not be allowed to take service under this Rider and will be served under Rider RTP-L or Rider RTP-LI for the electric power and energy supply provided by the Company. Terms and Conditions related to PRSS are specified in Rider RTP-L or Rider RTP-LI.

(Applicable to Customers at or above 1,000 kilowatts)

5. Customer with Self-Generation Capacity At or Greater Than 5,000 Kilowatts

A Customer served under this Rider that (a) owns, operates, and/or is entitled to the output from electric generating facilities located at such Customer's Premises, and (b) such generating facilities (1) have a generation capacity of 5,000 kW or more, and (2) are used for any purpose other than emergency purposes in the event and only during such times when electric power and energy supply service from the Company is interrupted is allowed to enroll for service under this Rider during the Open Enrollment Period for the Annual Contract Period. A Customer qualifying as a self-generator as defined above shall have its hourly kWh usage deducted from the Company-supplied power and energy and then allocated as Backup and Supplemental requirements as defined in Rider MV. The Backup requirement is equal to the kWh generation capability rating of Customer's generation facilities for each hour during the Billing Period. Any Backup used by Customer to replace such generation capability rating is served under Rider RTP-L. The Customer kWh usage in excess of the amount served by Customer generation or the energy classified as Backup, is considered Supplemental service and served pursuant to this Rider.
