**RIDER BGS – BASIC GENERATION SERVICE**  
**(Applicable to Customers Under 1,000 kilowatts)**

---

**PURPOSE**

Rider BGS – Basic Generation Service (Rider BGS), along with Delivery Service (DS) and Transmission Service (TS) tariffs contained within this Schedule, represents a continuation of bundled service for Customers in accordance with Section 16-103 (220 ILCS 5/16-103) of the Illinois Public Utilities Act (Act). Service under Rider BGS will be provided to those Customers served under Rate DS-1 – Residential Delivery Service (Rate DS-1), Rate DS-2 – Small General Delivery Service (Rate DS-2), Rate DS-3 – General Delivery Service (Rate DS-3), or Rate DS-5 – Lighting Service (Rate DS-5) who have not chosen service from an Alternative Retail Electric Supplier (ARES), Retail Electric Supplier (RES) (collectively RES), or Rider RTP – Real-Time Pricing (Rider RTP) for their supply option. This Rider provides Customers with electric power and energy supply from the Company procured pursuant to the provisions of the Company's Market Value of Power and Energy (Rider MV) tariff.

**AVAILABILITY**

This Rider is available, on and after January 2, 2007, to any Customer pursuant to the applicable requirements in the Terms and Conditions related to this Rider and Rider MV that elects to purchase electric power and energy supply from the Company and has given the Company the required notification as specified in the Customer Terms and Conditions. Where an existing Customer on Rider BGS experiences a Demand equal to or greater than 1,000 kilowatts (kW), said Customer may remain on Rider BGS, under the appropriate service classification, until the Company's next regularly scheduled start of the Annual Contract Period as defined in Rider MV, for Rider BGS-L – Basic Generation Service – Large (Rider BGS-L). If said Customer desires a continuation of electric power and energy supply service from the Company, then Customer shall be required to take service under Rider BGS-L, or in the alternative, select service under Rider RTP-L – Real-Time Pricing – Large (Rider RTP-L).

**SERVICE CLASSIFICATIONS**

The Customer's Delivery Service Rate is used to determine the Rider BGS service classification if the Customer elects or defaults to service under this Rider. The following are the Rider BGS service classifications and corresponding Delivery Service Rates – there are additional delineations for varying Delivery Voltages as shown in Rider MV, Appendix A.

**ELECTRIC POWER AND ENERGY SUPPLY PRICING METHODOLOGY**

Rider MV is used to determine the electric power and energy supply prices for this Rider. For each BGS service classification under Rider BGS, electric power and energy supply prices shall be billed on a per kilowatt-hour (kWh) basis. A monthly Market Value Adjustment (MVA), as defined in Rider MV, if applicable, will be applied to Rider BGS Customers to align electric power and energy supply costs for the BGS-FP Category, as defined in Rider MV, with Customer billings. The peak and off-peak periods are as defined in Rider MV.

**CHARGES**

For each Billing Period, Customer shall pay for electric power and energy supply at prices defined in Rider MV and stated on the applicable effective Retail Supply Charge Informational Filing. In addition, other charges will apply to Customers taking service under this Rider, including but not limited to, MVA, TS and any other applicable charges the Customer is required to pay as specified in the Delivery Service Rate.

**TERMS OF PAYMENT**

Customer bills for service under this Rider shall be rendered and payments due in accordance with the Payment of Bills and Late Payments provision of the Customer Terms and Conditions.

**TERMS AND CONDITIONS**

1. Service Obligation
  - A. Initial Assignment

Customers taking Company-supplied bundled service on January 1, 2007, will be assigned to Rider BGS based upon their Service Classification outlined above. Customers initially assigned to this Rider are not subject to a 12 month service obligation.

B. Subsequent to Initial Assignment

Customers returning to Rider BGS from RES supply service or from Rider RTP on a scheduled switch shall continue service under this Rider for not less than 12 consecutive months. Customers returning to Rider BGS on an unscheduled switch will have the opportunity to select other electric power and energy supply options no later than the second scheduled meter read after the date of the unscheduled switch. If no election is made, the Customer must remain on Rider BGS for a minimum of twelve consecutive months which begins from the date of the unscheduled switch.

2. Switching Rules

Customers electing to switch between electric power and energy supply options shall be subject to the Company's Direct Access Service Request (DASR) procedures, in accordance with the Switching Suppliers and DASR Procedures provision of the Customer Terms and Conditions, and the Retail Customer Switching Rules in Rider MV. If proper DASR notice is not provided, the Company shall follow the unscheduled switching provisions. Rider MV contains the rules for Customers selecting electric power and energy supply requirements from the Company. The Customer will be charged for each switch at the rate specified in Miscellaneous Fees and Charges.

3. Partial Requirements Supply Service

Customer requesting Partial Requirements Supply Service (PRSS), as defined in Rider MV, will not be allowed to take service under this Rider and will be served under Rider RTP for the electric power and energy supply provided by the Company. Terms and conditions related to PRSS are specified in Rider RTP.
